## **MEMO**Rev. Dr. Arvin Luchs

"Can we talk?" is the trademark opening for comedienne Joan River's chatty—sometimes catty—monologues. It's an important question to ask about our church today. It is precisely the question raised by Henry H. Knight III and Don E. Saliers in their book, *The Conversation Matters: Why United Methodists Should Talk with One Another*. (Abingdon Press, Nashville, TN, 1993).

"We should be listening and speaking," they write, "because...we are now in the midst of demanding tensions and conflicts, many of which strike at the root of Christian beliefs and practice. Churches and the whole American body politic find it increasingly difficult to discuss matters of essential importance without rancor." (p. 12) They are, of course, talking about those issues that stir controversy in our communities: abortion, warfare, same-sex marriages, stem-cell research and the like. And, they are talking about issues internal to the denomination: ordination and appointment of gay/lesbian pastors, revelation, the nature and authority of the scriptures, culture and the church, and so on.

The book, itself, was a product of intense conversation. Saliers and Knight are themselves on different sides of the theological and political fence.

The authors conclude that reasoned and extensive conversation is necessary for the church and society to find those values and ideals that bind them together into community. In civil discussions we not only grow in our understanding of differences, but discover the value of diversity and tolerance. Such discourse, they assert, is particularly important for United Methodists.

"Finally, it dawned on us that we *should* be speaking and listening to one another ... because we stand in a tradition that honors communal theological thinking. John Wesley insisted on this ...he termed it 'Christian conference,' and intended this as a practice internal to the life of Christian faith." (p. 12)

Soon after becoming your pastor I discovered a rich vein of open, honest—yet loving—conversation embedded in the life and culture of this congregation. I had a chance to glimpse it for myself in my first year as we grappled with the moralethical issues emerging from the events of 9/11 and the second war with Iraq. The conversations need to continue.

In the next few weeks we will have opportunity to participate in discussion of two substantial issues facing our church and our society.

On April 18<sup>th</sup> there will be a Forum titled, "The Discipline, The Constitution and Same Gender Marriage." (1:00 pm in Fireside Room.) Three outstanding leaders—from church and community will keynote the time, but the emphasis will be on our discussion and interaction.

On April 18<sup>th</sup> and again on April 25<sup>th</sup> a "Policy Review" will be held (9:15 am, Room 202) on a proposed policy regarding sexual offenders and First UMC. A task force has been working for almost a year to write a policy and suggest procedures that will assure our facility will be a "safe" place for everyone—especially the vulnerable—and yet offer, with significant safeguards—the services of the church to persons who have been accused or convicted of the sexual abuse. Our Leadership Council adopted the policy last year—but asked that hearings be held to receive input and 'perfect' the document before consideration at a Church Conference in May.

Youth—as well as adults are urged to participate in both events. They promise to be important moments of Christian "conferencing." Can we talk? I hope so!

### icv review regational Response Sought

On Sunday, April 18 and again on Sunday, April 25 at 9:15 am in Room 202 a policy statement on sexual offenders and First United Methodist Church will be introduced to the congregation. This is a sensitive but important topic. We urge the congregation and our youth to attend and participate in these sessions. Attend one or both of the sessions.

The introduction to the statement reads:

This Sex Offender Policy directly considers the issues of sexual abuse:

- to prevent sexual abuse of vulnerable persons, and
- to develop strong and caring guidelines when participants of our church are accused of sexual abuse or are convicted sex offenders returning to or joining - our church.

An underlying premise to our considerations is that we wish to respect two values of our church. We want to be inclusive and provide a church community to any person who wishes to participate. We are determined to provide a safe sanctuary for children, their families and vulnerable populations.

Each session will include: an introduction to the policy statement and its significance for the congregation in light of the Social Principles of our denomination and current national concerns about the sexual abuse of children and other vulnerable persons. The congregation will have an opportunity to ask questions and give input before it is placed before a May Church Conference for adoption. The task force is comprised of: Dr. Leif Terdal, John Henry Hingson, Janice Gratton, and the Rev. Dr. Arvin Luchs.

# Annual Conf.Project

This year's "parade of boxes" at Annual Conference will have a new twist - its a "parade of bags." And the parade leads to Portland's waterfront for donation to the Portland Seafarers Mission. About 25,000 sailors from poor and third-world countries visit Portland every year. Most are young and away from home for months at a time. Because of increased security measures, unless a sailor has a visa (which most do not), he must stay on board. Seafarers Mission provides various items and services for these sailors.

The following items are sought for donation to the Seafarers Mission: Bibles, religious materials, daily devotionals, small toilet articles (soap, shampoo, combs, toothpaste and brushes), paperback novels, magazines (especially National Geographic and sports), t-shirts, belts, pencils, pens, writing paper, envelopes, dominoes, cards and small games.

The items collected will be placed in large paper grocery bags, filled 1/3 full with as many different items in each bag as possible. Beginning the first Sunday in April, a collection box will be placed in the Narthex. Donations may be made of any and all of the above-listed items - and donations of filled bags are, of course, also welcome.

Seafarers Mission is also accepting donations of funds to use for transportation and telephone calls. Checks for this purpose may be made out to Conference Treasurer, marked as Conference Advance Specials/Portland Seafarers, and mailed to First UMC.

Raising Our Awareness of Evironmental Issues

Thank you, Trustees! The Planet Church Committee is pleased to announce that the Trustees of First UMC have approved the purchase of renewable energy to fulfill a portion of the electricity needs of the church. The Planet Church Committee estimated that it takes approximately 600 kWh of electricity to light the sanctuary each month and the Trustees have authorized the purchase of blocks of renewable energy equal to this amount.

While this is only a small amount of the church's electricity usage, this decision demonstrates our acknowledgement of the contribution of our church facility to global climate change and our commitment to take steps to mitigate our environmental impact.

The Planet Church Committee will continue to work with the leadership of First UMC to find ways of taking steps to lessen our environmental footprint.

# history & archives Dr. Raymond E. Balcomb, History & Archives, Chair

I know everyone isn't as interested in this as I am,

but I want to add something to the last piece I wrote upholding our claim to be "Portland's first church." I want to get it into print for future historians to chew on! The Oregon and California Mission Conference was authorized by the Methodist Episcopal General Conference in 1848. Before that time the workers here had been under the authority of the Board of Missions. Travel and communication times being what they were, the new Conference was not exactly organized until 1849, at which time its Superintendent, William Roberts,

reported five churches in Oregon: Oregon City and Portland, Salem, Yamhill, Mary's River (i.e.: Corvallis) and Astoria (plus a few in California). No mention of St. Johns, the only possible conclusion being that there wasn't any church there! A fact supported by another: none of the first Trustees of the St. Johns' M.E. Church moved to the St. Johns area until 1850 or later.
